**Dates:** 1832-1935, undated

**Extent:** 1.5 cubic ft. (3 document boxes and 1 oversize box, 156 documents)

**Administrative/Biographical History:** Antebellum is a Latin expression meaning "before war." In the context of United States history it is commonly used to refer to the period before the Civil War. The Civil War, also known as the War Between the States and several other names was fought between 1861-1865 after eleven slave states seceded from the United States and formed the Confederate States of America. The war ended when Confederate General Robert E. Lee surrendered to Union General Ulysses S. Grant at Appomattox Court House in Virginia on April 12, 1865.<sup>1</sup>

**Scope and Content:** This is a collection of documents, most of which chronicle the history of the American Civil War, particularly the Atlanta Campaign. In addition, there are several documents which reflect the history of the Antebellum South, including African American slavery. The collection includes letters, diaries, special orders, pardons, requisitions, poems, pamphlets, newspapers, personal narratives, biographies, circulars, broadsides, muster rolls, currency, bibles, research papers, and other private papers, publications, and government documents.

**System of Arrangement:** Arranged in three series: (1) Correspondence, 1856-1865, undated; (2) Government Documents, 1860-1935, undated; (3) Private Papers and Publications, 1832-1935, undated. Folders are arranged chronologically within each series.

**Conditions Governing Access:** This collection is open for research.

**Conditions Governing Reproduction and Use:** Unpublished manuscripts are protected by copyright. All requests to publish, quote, or reproduce must be submitted through the Kenan Research Center.

**Existence and Location of Copies:** Typed transcriptions of original letters in box 1 are contained in box 2.

**Description Control:** Collection reprocessed in 2008.

## Descriptive Inventory:

### Series 1: Correspondence, 1856 – 1865, undated (42 documents)

The series includes correspondence, including letters and diaries of Union and Confederate soldiers during the Civil War, mostly during the Atlanta Campaign in the spring and summer of 1864. An exception is a letter written in 1856 from an Atlantan expressing fears of a slave revolt. Each entry lists the correspondent (when identified), their location (in italics) and to whom they are writing. Units for both Union and Confederate correspondents are sometimes identified; otherwise the correspondent is listed as either Union or Confederate. The letters are organized in chronological order. Notable correspondents include General Robert E. Lee, William Tecumseh Sherman, Georgia Governor Joseph E. Brown, and Atlanta pioneer William Austin Leyden. Letters from Confederate soldiers from Georgia include subjects such as the formation and movements of military units, descriptions of camp life, a description of a Baptismal ceremony, a sympathy letter to family members of a fallen soldier, and a first-hand description of the battle of Kennesaw Mountain, and the fall of Atlanta. Many of the letters from Georgia soldiers were written in combat theaters across the Southeast including Yorktown, Richmond, and Petersburg, Virginia, as well as Vicksburg, Mississippi. Also included in this series is correspondence from other Confederate and Union soldiers in camps throughout Georgia during the Atlanta Campaign, which describes fighting near Dallas, Marietta, Kennesaw, Roswell, and Atlanta, as well as the latter stages of the conflict in Georgia. Correspondence from Union soldiers includes diaries and letters written in 1864-1865. Included are accounts from soldiers serving in infantry and cavalry units from Illinois, Ohio, Connecticut, and New York. The diaries of these soldiers consist of hundreds of entries, many only 3-4 lines, but some spanning multiple pages, describing camp life, soldier provisions, the landscape, Confederate fortifications surrounding Atlanta, the weather, health and ailments, caring for wounded soldiers, rumors of the movements of Confederate forces, battles and skirmishes, the death of General James B. McPherson in battle, the capture and occupation of Atlanta, and the Confederate prison at Andersonville, Georgia.

## **Series 2: Government Documents, 1860-1935, undated (59 documents)**

This series is largely comprised of military records, including special orders, muster rolls, general orders, financial documents, requisitions, circulars, and ordinance reports. The documents are organized chronologically. Other records include those issued by state governments after the war, including pardons. Many of the military records are special orders issued for the Georgia Militia or the Fulton County Militia in Atlanta. The orders include calls for arming and equipping all men eligible to serve in the militia, monthly regimental parades, elections of field officers, granting leave of absences, the impressment of Atlanta's City Hall as a hospital, details of civilians for duty, and service exemptions for newspaper employees, including Samuel P. Richards of *The Soldiers Friend*, and editors and publishers of *The Baptist Banner*. The series include muster rolls for the 1<sup>st</sup>, 4<sup>th</sup>, and 7<sup>th</sup> Georgia Regiments in 1861-1862, and for the 144<sup>th</sup> New York Volunteers. Among the records issued by state governments are pardons to ex-Confederate soldiers and officials, an invoice for "impressment of negroes" in Alabama to make salt, and a letter from General Robert E. Lee dismissing soldiers of the Army of Northern Virginia after the surrender at Appomattox.

This series features personal papers of Georgia citizens and other individuals and published documents. Private papers include an estate appraisal, a receipt, and an indenture, all of which document the ownership of slaves. Also included are pieces of Confederate currency and poems. Publications mostly include pamphlets containing reprinted speeches and letters by Alexander Stephens, General Joseph Hooker, Ulysses Grant, Abraham Lincoln, William Tecumseh Sherman, Joseph E. Brown, Jefferson Davis, and Howell Cobb. Also included is a published diary from a Confederate soldier, pamphlets created for reunions of Joseph Wheeler's Cavalry unit, Civil War sheet music, a soldier's pocket bible, and biographies of Confederate soldiers.
